

MEMBERSHIP TERMS NUDGD ACADEMY

Nudgd Academy is operated by Nudgd. Through your organisation's membership in Nudgd Academy, you receive information with news, research updates, invitations, offers and opportunities to participate in activities arranged by Nudgd Academy and Nudgd.

1. MEMBERSHIP

Here you can read the terms and conditions for membership in Nudgd Academy.

1.1 Membership in Nudgd Academy is available only to legal entities. Private individuals cannot become members.

1.2 Membership in Nudgd Academy costs as follows:

- Non-profit organisations: €500/year
- Company/organisation, up to 10 employees: €500/year
- Company/organisation, more than 10 employees: €1,000/year
- Municipality, region, government authority or other public-sector organisation: €1,000/year

VAT of 25% will be added.

1.3 The membership fee is invoiced annually with 30-day payment terms.

1.4 The membership fee may be changed. All existing members will be informed by email of the new membership fee and how the change affects them no later than 60 days before the next annual membership period takes effect.

1.5 The membership runs annually until further notice. Cancellation must be made by email to jessica.viktorsson@nudgd.se no later than 30 days before the next annual membership period begins. For example, if you became a member on 1 January 2023 and do not want the membership to renew for 2024, written cancellation by email must be received by Nudgd Academy no later than 2 December 2023.

1.6 Any unused months or membership benefits are non-refundable.

1.7 When you enter into a membership, all information about the membership is sent to the email address of the designated contact person.

1.8 The member is responsible for keeping up to date with the terms and content of Nudgd Academy. These are always available at: <https://www.nudgingsweden.org>

1.9 Registering for membership means that the member accepts the membership terms of Nudgd Academy.

1.10 Nudgd Academy reserves the right to terminate the membership in the event of misuse of the membership.

2. OTHER

2.1 Nudgd Academy is an online-based service. Communication with members therefore takes place primarily via the Internet, social media and email.

2.2 Nudgd Academy will use the membership register/member database to tailor relevant information, marketing and marketing communications to members.

2.3 Nudgd Academy reserves the right to make changes to published material and to benefits, discounts and prices.

2.5 Nudgd Academy reserves the right to change or terminate membership without prior notice or compensation.

2.6 When the membership is terminated, information about the member will be deleted from the membership database.

2.7 If the member changes name, address, email or telephone number, the member must notify Nudgd Academy in writing by email to jessica.viktorsson@nudgd.se so that Nudgd Academy has up-to-date information about the member.

2.8 By accepting these membership terms in connection with the membership application, the member consents to Nudgd Academy having the right to store member details and information for use in marketing and communication by post, email, telephone, social media or SMS.

2.9 The registered personal data will only be processed and stored in order to provide information about and administer the membership, and to coordinate offers and activities with Nudgd Academy's collaboration partners.

2.10 Disputes concerning the membership terms are governed by Swedish law. Disputes shall be decided by Swedish courts.
